Rides for approval

The following rides were mentioned in the report for the October meeting which did not proceed.

Tom Quilty /Tooraweenah – 24-25 Sept 2021 OR 9-10 July 2021 – 160km. Discussed elsewhere in these minutes.

State Champs – Kowen Forest ACT – 6, 7, 8, June 2020. Discussed elsewhere in these minutes.

Upper Corindi - NR zone (info only) 28-29 March 2020. Northern Rivers. No discussion needed.

Kowen Forest – 11-12th April 2020 – 20, 40, 80km (alternate 6-7 June 2020). **Hold over.**

Scenic City Starter – 15-16 Feb 2020 – 10, 20, 40km. **Approved.**

Woodstock 12 and 13 September, 20, 20, 40, 80 on the Sunday. Approved.

Mogendoora – 4 and 5 July 5 and 20 and then 40 and 80 on the Sunday. It is the week before Q60 but it is over 200 k away. **Approved.**

Ruth Sumpner – concerned about Glen Innes on the same weekend as Minimbah ride. Glen Innes is included in the QERA calendar so we assume the ride is now booked with QERA. Unfortunately we have to dual affiliate NRZ rides. Bumbaldry changed their ride date to help this ride out last year. Jo said from the AERA website it appears that Tenterfield were running in July. Agreed to write to QERA expressing concern about conflicting rides and seeking better communication.

Standing Items

State Championship 2020

Three EOIs received, for rides at Tumut, Windeyer and Kowen Forest. The SMC is grateful to these clubs for their interest. All three committees suggest the June long weekend. Conflicts of interest were discussed. The proposals were carefully considered with lengthy discussion. A vote followed with majority support for the Tumut proposal. Kerry will advise the successful committee. Jo will advise the unsuccessful committees. The \$6,000 SMC support could be presented at the AGM.

AERA meetings Peter Bice. Next meeting 16/17 November 2019

The report below was sent in for the October meeting which did not go ahead.

The next AERA meeting is 16th 17th November. There hasn't been a lot happen since the last SMC meeting. There has been more correspondence from the RSPCA and this will be discussed at the next AERA meeting. The latest draft of the new constitution is available for comment now, hopefully this will be the final version. We are watching with interest the developments in the racing industry as to what happens to failed race horses.

Kerry is unable to attend due to family commitments, agreement given that Kerry will give her proxy to Noni. AERA agenda sent out.

Faith: At the AERA meeting are you going to be discussing compression hoods? The Zone One committee is interested in this issue, covered later in this report.

Agenda items in brief:

- Suggestion to increase the rider fees, potentially from \$4 to \$5 will give an increase in income of \$9,186.00. **NSW SMC does not support this, delegates to vote against.**
- Endurance horse registrations proposed fee increase, with no figure given yet. NSW SMC does
 not support this motion, delegates to vote against. Belinda commented on the expense of
 getting people into the sport.
- Honorariums motion to say that the honorariums be increased by CPI or 2.5% whichever is the greater. NSW SMC does not support this, delegates to vote against.
- Increase to ride vet fees. **NSW SMC does not support this, delegates to vote against**. Noted the drought is affecting a lot of people and places, somewhat surprising we are getting as many horses at rides as we are. It appears the general economy is stalling. No point or justification in increasing vet fees. .
- Emergency transport cover for volunteers: we have asked AERA to include this in the 2020 policy.
 There is a note in the Newsletter advising volunteers that they need their own ambulance cover until this sorted in the AERA policy.
- Any comments on the Quilty Manual/event standard please send in.
- Discussion on standardised arrows.
- Motion from QERA to go with the NSW motion concerning novice horses without log books. A horse
 that enters three introductory rides in a year must have a log book, rationale given. Discussion took
 place, it may be an unenforceable rule as riders need to be a member of the Association for a log
 book. Essentially we would therefore be abolishing day membership. More likely to push people
 away rather than increase our membership. NSW SMC does not support this, delegates to vote
 against.
- Compression hoods: VERA raises concern about inconsistencies with enforcement of this rule but no motion put forward. Faith commented that this issue was discussed by Zone One who want to move a motion that compression hoods be allowed in vet rings. Anyone would be able to use one and no one is disadvantaged. Matthew noted they are supposed to calm horses down. Does Rule 63.9 apply to hoods? Refers to tack and is a grey area. Consensus that the SMC is supportive of hoods being allowed. Agreed to put a motion to the AERA meeting to support use of hoods in vetting.

MOVED the committee, the committee

THAT a new rule be submitted to the AERA that compression hoods be allowed at all veterinary inspections. **Carried** Unanimous

2019 NSW Office of Sport Grant project – Advertising campaign Earlier report included here for comprehension of what is to follow.

Actual advertising will probably be arranged and therefore spent, in two halves. One for the last half of this year and then the second half for the beginning of next year.

- Computers, software, Adobe all to be organised with computers hopefully to be purchased before the end of the year., includes software, one per zone.
- First aid kits to be purchased. John feels we need kits for serious trauma. Consider buying waterproof storage boxes.
- scanners for CSs. Allow for neck splints and other things than be added. Article on PIC numbers to be done by John for newsletter.

Kerry: Close to presenting a range of computers for selection for the grant money. Can the Zone delegates make sure there is someone who can take charge of these computers. If there is anyone who feels they do not need a computer they should let Kerry know.

Kim: the timing system is going to be on tablets as of January. AERAspace can also run on tablets. Kim said they want to be able to introduce the iPad or a tablet so that two or three people will be able to enter at the same time. The ETS has its own wifi. Peter said his understanding is that the tablets will not replace the ride computer.

Also the best news is that all rides have exceeded their estimated target income so we are \$3,033.00 ahead of estimated budget. I refer you all to the profit and loss sheet. At this time last year we were running at a loss of \$2,558.00. To date after removing the unexpended Tied Grant residue of \$26,389.28 we are currently running at a profit of \$20,990.89. We are still on track to return the first surplus in several years. But consider that we still have some large costs to come in the form of annual trophies and sashes.

Therefore, I recommend that for 2020 we reset all fees and membership costs at the same rate as 2019. Possibly, the best news is that for the first time since 2015 our membership numbers have stabilised, which bodes well for the future. Increased membership will ease the burden on members.

Newsletter: - The November December Newsletter is under way and coming along well. With one exception, all Ride Organisers have provided Ride reviews/ Previews to the Editor, we have to keep in mind that the Newsletter is still the Principal communication vehicle to our membership. It is essential that all members support our Newsletter so that we may all be on the same page, information wise.

Zone Two: Last weekend Windeyer ran the Zone's second last ride for the year. While numbers were down the ride was a success from the point of view of the riders and made money for the club. In fact the Committee were so excited by the result that they wish to tender for the 2020 State Championship ride. The Club realises that they have passed the deadline but would like to be considered as:

Club Members are all battling the worst drought in Australia's history and were not sure how successful last weekend's ride would be. Club Secretary is in the late stages of Pregnancy and has a small child already, to care for. Time is of the essence. The club wanted to, and did, totally commit to the weekends ride, to make it

as successful as possible. Finally, it would be nice to have a choice of Clubs offering to host the States premier ride.

Tooraweenah continues with the planning for TQ21.Community interest is extremely high and the organisers are using TQ21 as a Community exercise to take the focus from the drought that is crippling the local farming community.

The last ride of the year will be the Bullio Cup set down for the weekend of 2 and 3 of November,

Zone Two The Best In The West.

Also from next Monday to Friday 1st November I will be on active service with the NSW Rural Fire Service. I have been tasked to the Northern Rivers fires in the Casino area.
