Robert Pierce: financial planning

Robert (Bob) Pierce was asked to attend the meeting to advise the SMC on our current and future financial situation. Bob noted that some organizations do not look at their balance sheet until the end of the year. In 2016 we had \$80,000 retained savings, now \$66,000. One of the main income sources was the Sports Development Grant. Bob asked whether this is a one off. The \$6,000 has been recurrent, but the \$25,000 project grant is probably a one off. Kerry brought Bob up to date on how the grant situation worked. In summary we are down \$21,000 for 2017. Issues discussed: ride booking fees down approximately \$13,000, merchandise was more than usual because of TQ15, AERA expenses up by \$3,800, being the \$3 levy put on all the States by the AERA. John advised Bob on how this levy came into being, noted 10% of our income goes to the AERA. Annual awards costs also increased, mainly horse head trophies. The Association needs to set and adhere to a budget. Bob advised that we might be better to use an online accounting system, this would cost around \$17.50/month and all authorized people could view the records.

2017 AGM debrief

Agreed to reinstate the year on the proxy forms. Discussion about how to resolve the dilemma of the contradictory motions passed at the AGM. Tony advised that the executive has sought legal advice and created a solution that they feel solves the issues and avoids the need for a special meeting. Hopefully the rest of the SMC will agree. Recommendations were discussed, with the final wording agreed to as set out below.

MOVED THAT

in order to resolve the contradiction of motions 1, 2 and 3 carried at the 2017 AGM, and in accordance with legal advice NSW ERA adopt recommendations 1 to 5 below

- 1. The SMC agree to apply the AGM motions 1, 2 and 3 as suggested by our legal advisor, that is, no vaccination requirements will be considered for any NSW ride other than Zone 6 and the NRZ.
- 2. If a ride committee in Zone 6 can demonstrate through its risk assessment that a vaccination requirement is necessary to allow a ride to go ahead, then the SMC will consider allowing a vaccination requirement, but only for horses normally living in the Hendra affected areas identified by the NSW Department of Primary Industries.
- 3. If a ride committee in the NRZ can demonstrate through its risk assessment that a vaccination requirement is necessary to allow a ride to go ahead, then the SMC will consider dual affiliating the ride only if the vaccination requirement applies to horses normally living in the Hendra affected areas identified by the NSW Department of Primary Industries.
- 4. That the SMC state its position as being that vaccination requirements will only be accepted if supported by a risk assessment, for rides in Zone 6 and the NRZ, and then only for horses normally living in the 'Hendra affected areas' nominated by the NSW Department of Primary Industries.
- That this position be trialled for 2018 with the opportunity for change at the next AGM.

I am confident that we'll exceed our last year's ride affiliation fee income quite nicely. As a start to our year of austerity I'd like to start with all SMC members buying their own dinner at SMC meetings this year, this will result in a saving of almost \$1,000.00. I shall speak on Alam Dastani at the meeting, as he has some strategies to help us.

Ride Calendar:-

The year is filling beautifully, Friday night we have three new rides to approve and this will leave very few gaps. The policy of one ride per weekend has worked well and by and large has been well accepted.

This year I wish to concentrate on the Treasury. I would like to commend Jo Davis to you all as the person I feel should fully take over the ride calendar. 2017 has seen Jo do a fantastic job, I believe that her organisational and negotiation skills are excellent for the ride calendar and I feel that we should confirm her in this most vital portfolio.
